MEMORANDUM OF ASSIGNMENT OF LEASE

THIS MEMORANDUM OF ASSIGNMENT OF LEASE is made and entered into as of July 23, 2014, by and between INFINITY TRANSPORTATION III LLC (the "Assignee") and PNC EQUIPMENT FINANCE, LLC (F/K/A PNC LEASING, LLC) (the "Assignor"), with reference to the following:

Assignor, as successor to PNC Leasing, LLC, as successor to ICX Corporation, as Lessor, and Interstate Power and Light Company as successor to IES Utilities Inc., as Lessee, have heretofore executed that certain Master Rail Lease Agreement No. 1051 dated as of April 10, 2000, as amended by that certain Amendment to Lease dated January 1, 2002 (collectively, the "Agreement"), and, pursuant thereto, that certain Equipment Schedule No. 001, executed by Lessor on April 18, 2000 and Lessee on April 17, 2000 (the "Equipment Schedule No. 001," together with the Agreement and all documents and instruments executed in connection therewith, collectively, the "Lease"), pertaining to the railcars described therein and further described on Exhibit No. 1 attached hereto (the "Railcars").

A Memorandum of Lease as to Equipment Schedule No. 001 was recorded with the Surface Transportation Board on April 18, 2000, under Recordation No. 22897.

Upon the execution of the Master Assignment Agreement, dated September 24, 2001, between ICX Corporation, as assignor, and PNC Leasing, LLC, as assignee, a Memorandum of Assignment of Lease as to Equipment Schedule No. 001 was recorded with the Surface Transportation Board on September 25, 2001, under Recordation No. 22897-A.

Assignor and Assignee have executed that certain Purchase Agreement (railcars and leases) dated as of the date hereof, pursuant to which Assignor has assigned to Assignee all of its rights and obligations under the Lease with respect to the Railcars.

The parties hereto wish to show for public record this Memorandum of Assignment of Lease to provide notice of such assignment.

This Memorandum of Assignment of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment of Lease.




