
THIS TERMINATION OF LEASE (No. 47-CO) is made and entered into as of July 15, 2016 by and between TTX LEASE 47-CO TRUST ("*Owner*") by Wilmington Trust, National Association (as successor to FMB Trust Company, National Association), not in its individual capacity but solely as trustee of TTX Lease 47-CO Trust ("*Owner Trustee*"), and TTX COMPANY, as lessee ("*Lessee*").


