MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE
(Surface Transportation Board)
(Schedule #5)

THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE (this "Memorandum") dated as of September 25, 2014 is between MIDWEST RAILCAR CORPORATION (the "Assignor") and BB&T EQUIPMENT FINANCE CORPORATION (the "Assignee").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. The Assignor, as lessor, has leased to OmniSource Corporation, as lessee (the "Lessee"), twenty (20) railcars identified on Schedule 1 attached hereto (the "Railcars") under that certain Schedule #5 dated as of December 21, 2012, as amended by that certain First Amendment of Schedule #5 dated as of July 24, 2013 (the "First Amendment"), each by and between Assignor, as lessor, and Lessee, as lessee, to the Master Railcar Lease Agreement dated as of December 21, 2012 by and between Assignor, as lessor and Lessee, as amended by the First Amendment (collectively, as amended, the "Lease"). The Memorandum of Schedule #5 to Master Railcar Lease Agreement dated as of December 21, 2012 by and between the Assignor, as lessor, and the Lessee, as lessee, was filed with the Surface Transportation Board under recordation number 30868.

B. The Assignor, as assignor, and the Assignee, as assignee, are parties to that certain Assignment of Lessor's Interest in Lease and Guaranty, dated as of even date herewith, pursuant to which the Assignor has assigned to the Assignee the rights of "Lessor" under the Lease. The terms of the assignment are more particularly set forth in the above-referenced Assignment of Lessor's Interest in Lease and Guaranty.

C. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first above written. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.
