**MEMORANDUM OF ASSIGNMENT**

THIS MEMORANDUM OF ASSIGNMENT dated as of February 29, 2016 (the “**Memorandum**”), is between GREENBRIER LEASING COMPANY LLC, an Oregon limited liability company (“**Transferor**”), and RIVERSIDE RAIL I LLC a Delaware limited liability company (“**Transferee**”).

The parties to this Memorandum hereby acknowledge and confirm the following:

A. Transferor, as lessor, has leased certain railroad cars more particularly described in Exhibit A attached hereto (the “**Cars**”) to Minnesota, Dakota and Western Railway Company pursuant to that certain Rider No. 1 dated as of March 1, 2013, and effective August 1, 2010 (as amended, modified, extended, supplemented, restated and/or replaced from time to time, the “**Schedule**”), to that certain Master Lease Agreement dated as of March 1, 2013, and effective August 1, 2010 (as amended, modified, extended, supplemented, restated and/or replaced from time to time, the “**Master Lease**”, and the Schedule, together with the Master Lease as it pertains to the Schedule, the “**Lease**”).

B. A Memorandum of Lease was filed with respect to Rider No. 1 with the U.S. Surface Transportation Board on July 17, 2013, at 3:00 p.m., under recordation number 30843.

C. Transferor and Transferee are parties to that certain Assignment Agreement dated February 29, 2016, pursuant to which Transferor has assigned all of its right, title and interest under the Lease, as it pertains to periods on and after February 29, 2016, and the Cars, to Transferee.


