RELEASE OF
COMMERCIAL SECURITY AGREEMENT

THIS RELEASE OF COMMERCIAL SECURITY AGREEMENT (this "Release") is dated effective as July 31, 2012 (the "Effective Date"), and is executed by Bank of Blue Valley (the "Lender") in favor of RAIL LOGISTICS, L.C. (the "Borrower").

RECITALS

WHEREAS, Borrower and Lender entered into a certain Commercial Security Agreement dated effective May 6, 2004, along with Amendment dated November 22, 2011 (the "Security Agreement"; capitalized terms used herein without definition shall have the meanings assigned in the Security Agreement); and the other loan documents described in the Security Agreement, pursuant to which Borrower has obtained certain credit from Lender; and

WHEREAS, pursuant to the Security Agreement Borrower granted to Lender a security interest in and to certain rail cars listed in "EXHIBIT A" (the "Collateral"); and

WHEREAS, Borrower has requested that Lender release the Collateral, and Lender has agreed to do so.

AGREEMENTS

NOW, THEREFORE, in consideration of the mutual agreements contained herein, and for other good and value consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows;

1. Rail Cars. Lender hereby releases any interest it has in and to the rail cars listed on Schedule A attached hereto and hereby releases the same from the lien of the Security Agreement.
2. Miscellaneous. Paragraph headings are for convenience of reference only and shall not be considered in interpreting this Release. If a court finds any provision of this Release to be unenforceable, such provision shall be severed herefrom and the other provisions shall remain in full force and effect.
3. Further Assurances. Lender agrees to do, execute, acknowledge and deliver any and all other documents and instruments and to take all such further action as shall be necessary or desirable to fully carry out this Release and to fully consummate and effect the release contemplated hereby.
4. Governing Law. This Release shall be governed by and construed in accordance with the internal laws of the State of Kansas.
