

**MEMORANDUM OF ASSIGNMENT**

This **MEMORANDUM OF ASSIGNMENT** is dated as of May 2014, by and between **COMPASS RAIL VI CORPORATION**, a California corporation ("**Seller**") and **FIRST UNION RAIL CORPORATION**, a North Carolina corporation ("**Purchaser**").

The parties to this Memorandum hereby acknowledge and confirm the following:

1. Seller, as lessor, has leased certain railroad cars more particularly described in Exhibit A attached hereto (the "**Cars**") pursuant to that certain Master Lease Agreement dated as of October 2, 2009, Rider No. 3, Rider No. 4, Rider No. 6, Rider No. 7, and Rider No. 8 thereto (Rider No. 3, Rider No. 4, Rider No. 6, Rider No. 7, Rider No. 8 and the Master Lease Agreement as it pertains to Rider No. 3, Rider No. 4, Rider No. 6, Rider No. 7, and Rider No. 8, each as amended, modified, extended, supplemented, restated and/or replaced from time to time, the "**Lease**") to RheTech, Inc.

2. An Amendment No. 1 to Memorandum of Lease and Collateral Assignment of Lease was filed with the U.S. Surface Transportation Board on September 11, 2012 under recordation number 29504-D.

3. A Memorandum of Lease and Collateral Assignment of Lease was filed with the U.S. Surface Transportation Board on July 22, 2011 under recordation number 29504-B.

4. An Amendment No. 1 To Memorandum of Lease and Collateral Assignment of Lease was filed with the U.S. Surface Transportation Board on September 7, 2012 under recordation number 29866-A.

5. A Memorandum of Chattel Mortgage was filed with the U.S. Surface Transportation Board on August 19, 2011 under recordation number 29866.

6. Purchaser and Seller are parties to that certain Purchase and Sale Agreement dated as of May, 2014 and Assignment Agreement dated as of May, 2014, pursuant to which Seller has agreed to sell to Purchaser the Cars and assign and transfer to Purchaser all of Seller's rights, title and interest under the Lease, and Purchaser has agreed to purchase the Cars and agreed to the assignment.

7. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first above written. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.
