MEMORANDUM OF TERMINATION OF LEASE

Memorandum of Termination of Lease dated as of December 4, 2013 by Mitsui Rail Capital, LLC (as successor in interest to JAIX Leasing Company), a Delaware limited liability company ("**Lessor**").

WITNESSETH:

1. Lessor and Gulf Power Company (the "**Lessee**") are parties to that certain Railcar Equipment Lease (the "**Equipment Lease**"), dated December 16, 2008, and Rider 2 thereto dated as of December 16, 2008 (the "**Rider**"), whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars described in such Rider. (The Rider, incorporating the terms of the Equipment Lease, is herein referred to as the "**Lease.**")
2. Notice of the Lease has been put of record by the filing of a Memorandum of Net Lease Agreement dated as of December 16, 2008 with the Surface Transportation Board on April 8, 2009 under Recordation Number 27869.
3. The Lease has been terminated.
