

MEMORANDUM OF COMMERCIAL SECURITY AGREEMENT

This **MEMORANDUM OF COMMERCIAL SECURITY AGREEMENT** (this "Memorandum"), is entered into effective as of July 14, 2010, by and among **MOBILE SERVICES & EQUIPMENT, INC.**, an Illinois corporation ("Mobile Services"), **BENJAMIN K. FORGERY III** ("Guarantor"), and **FIRST MIDWEST BANK**, an Illinois banking corporation and its successors and assigns ("Lender").

1. Pursuant to that certain Business Loan Agreement dated as of July 14, 2010, by and among Mobile Services, **INDUSTRIAL RAILWAY SWITCHING & SERVICES, INC.**, an Ohio corporation ("IRSS"), **MOBILE LOCOMOTIVE SERVICES, INC.**, an Illinois corporation ("Mobile Locomotive" and collectively with Mobile Services and IRSS, the "Borrowers" and each a "Borrower"), and Lender (the "Loan Agreement"), Lender has made two loans to Borrowers (the "Loans").

2. The Loans are secured under and pursuant to, among other things, that certain Commercial Security Agreement executed and delivered by Mobile Services in favor of Lender dated as of July 14, 2010, pursuant to which Mobile Services granted to Lender a first lien and security interest in all Mobile Services assets, including, but not limited, to any and all Mobile Services rights, title and interest in and to those locomotives listed on Exhibit A attached hereto.

3. Pursuant to that certain Commercial Guaranty executed and delivered by Guarantor in favor of Lender dated as of July 14, 2010, Guarantor guaranties all payment and performance of all obligations of Borrowers to Lender.

4. Counterparts. This Memorandum may be executed in one or more counterparts, each of which shall be deemed an original, but all of which shall be one document.




