(successor by assignment to Bank of Hawaii Leasing, Inc.), as Lessor (the "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby gives notice that it has terminated the Master Lease Agreement, dated as of September 30, 1998, and Equipment Lease Schedule No. 32699-01 dated September 30, 1998, as amended, modified or supplemented (the "Lease"), with CHICAGO FREIGHT CAR LEASING CO., as Lessee (the "Lessee").






