RAILCAR COLLATERAL SCHEDULE TERMINATION

This Railcar Collateral Schedule Termination dated as of October 16, 2015, is between SUNTRUST EQUIPMENT FINANCE & LEASING CORP., as "Secured Party", and TRINITY CHEMICAL LEASING, L.L.C., as "Debtor."




