MEMORANDUM OF TERMINATION OF LEASE


Memorandum of Termination of Lease dated as of July 1, 2014 by Mitsui Rail Capital, LLC, a Delaware limited liability company ("**Lessor**").

WITNESSETH:

1. Lessor and Kincaid Generation, L.L.C. (the "**Lessee**") are parties to that certain Full Service Lease Agreement (the "**Lease Agreement**"), dated December 21, 2012, and Schedule No. 1 thereto dated as of December 21, 2012 (the "**Schedule**"), whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars described in such Schedule. (The Schedule, incorporating the terms of the Lease Agreement, is herein referred to as the "**Lease**.")
