

MEMORANDUM OF LEASE TERMINATION
(INDIANA MICHIGAN TRUST NO. 91-2 AND 91-3)

THIS MEMORANDUM OF LEASE TERMINATION (this "*Memorandum*") is made and entered into as of September 25, 2015 by and between INDIANA MICHIGAN POWER COMPANY, an Indiana corporation (the "*Lessee*"); U.S. BANK NATIONAL ASSOCIATION, a national banking association, not in its individual capacity, but solely as owner trustee under each of the Trust Agreements (as defined below) (each an "*Owner Trustee*" or "*Lessor*"); and MANUFACTURERS HANOVER LEASING INTERNATIONAL CORP., a Delaware corporation (the "*Owner Participant*").

1. The Owner Participant and the Owner Trustee are parties to the Trust Agreement (Indiana Michigan Trust No. 91-2) and the Trust Agreement (Indiana Michigan Trust 91-3), each dated as of July 1, 1991 (each as amended and supplemented to the date hereof, a "*Trust Agreement*") collectively pursuant to which the Owner Trustee holds legal title to the 551 110-ton gondola coalporter railcars described therein (the "*Equipment*").

2. The Lessor and Lessee are parties to that certain (i) Railcar Lease (Indiana Michigan Trust No. 91-2) and (ii) Railcar Lease (Indiana Michigan Trust 91-3), each dated as of July 1, 1991 (each Railcar Lease, as amended, modified and/or supplemented, an "*Equipment Lease*") pursuant to which Lessee leased the Equipment from Lessor (which Equipment Lease for Indiana Michigan Trust 91-2 was recorded with the Surface Transportation Board ("*STB*") on August 2, 1991, under recordation number 17462 and Equipment Lease for Indiana Michigan Trust 91-3 was recorded with the STB on August 2, 1991, under recordation number 17463.

3. The undersigned parties do hereby give notice of the termination of the Equipment Leases, the Trust Agreements and each of other Operative Agreements (as defined in the respective Equipment Lease) effective as of the date hereof with respect to the Equipment subject thereto.

4. This Memorandum of Lease Termination shall neither impair nor terminate the rights, obligations, liabilities, duties or claims and demands of the parties pursuant to any indemnification or other provision under any Equipment Lease, or other Operative Agreements which by its terms expressly survive termination.

5. It is expressly understood and agreed that (a) this Memorandum of Lease Termination is executed and delivered by U.S. Bank National Association, not individually or personally but solely as Owner Trustee under each Trust Agreement, (b) any representation, undertaking or agreement herein made on the part of Lessor is made and intended not as a personal representation, undertaking

and agreement by U.S. Bank National Association and (c) under no circumstances shall U.S. Bank National Association be personally liable for the payment of any indebtedness or expenses of Lessor or be liable for the breach or failure of any obligation, representation, warranty or covenant made or undertaken by Lessor hereunder.


