MEMORANDUM OF TERMINATION OF LEASE

Memorandum of Termination of Lease dated as of June 1, 2014 by Mitsui Rail Capital, LLC, a Delaware limited liability company ("**Lessor**").

WITNESSETH:

1. Lessor and Steelscape, Inc. (the "**Lessee**") are parties to that certain Lease Agreement (the "**Lease Agreement**"), dated October 5, 2005, and Schedule No. 2 thereto dated as of April 3, 2009 (the "**Schedule**"), whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars described in such Schedule.
