MEMORANDUM OF ADDITIONAL COLLATERAL

This Memorandum of Additional Collateral is made and entered into as of March 20, 2014, by and among THE GREENBRIER COMPANIES, INC. (the "Borrower"), BRANDON RAILROAD LLC, GREENBRIER-CONCARRIL, LLC, GREENBRIER LEASING COMPANY LLC, GREENBRIER LEASING, L.P., GREENBRIER LEASING LIMITED PARTNER, LLC, GREENBRIER MANAGEMENT SERVICES, LLC, GREENBRIER RAILCAR LLC, GREENBRIER RAILCAR LEASING, INC., GUNDERSON LLC, GUNDERSON MARINE LLC, GUNDERSON RAIL SERVICES LLC, GUNDERSON SPECIALTY PRODUCTS, LLC, MERIDIAN RAIL ACQUISITION CORP., MERIDIAN RAIL HOLDINGS CORP., MERIDIAN RAIL MEXICO CITY CORP. and AUTOSTACK COMPANY LLC (the "Subsidiary Guarantors", together with the Borrower, collectively, the "Debtors" and each a "Debtor"), and BANK OF AMERICA, N.A., as agent (in such capacity, the "Administrative Agent") for the lenders party to the Credit Agreement (the "Lenders"), respecting (i) that certain Second Amended and Restated Credit Agreement dated as of June 30, 2011 (as amended or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, the Administrative Agent and the Lenders, and (ii) that certain Second Amended and Restated Security Agreement dated as of June 30, 2011 (as amended or otherwise modified from time to time, the "Security Agreement"), entered into between the Debtors and the Administrative Agent.


This Memorandum of Additional Collateral is in addition to and supplements that certain Memorandum of Credit Agreement and Security Agreement dated as of June 30, 2011 recorded on June 30, 2011 under Recordation Number 25820-P (the "Memorandum").

Debtors and the Administrative Agent hereby affirm and acknowledge that: (a) the Lenders have agreed to loan to the Borrower, the Borrower has agreed to borrow from the Lenders, and (b) the Debtors have agreed to grant the Administrative Agent, for the benefit of itself and the holders of the Secured Obligations (as defined in the Security Agreement), a security interest in (i) certain railroad equipment identified by reporting marks and road numbers as listed on Schedule A hereto and all accessions to each of the foregoing (collectively, the "Additional Pledged Railcars") and (ii) in all leases by each Debtor or its successors and/or assigns of the locomotives, railcars (including the Additional Pledged Railcars) and other rolling stock of the Debtors, whether now owned or hereafter acquired, from time to time pledged under the Security Agreement while such locomotives, railcars (including the Additional Pledged Railcars) and other rolling stock subject to the applicable lease are pledged under the Security Agreement, whether such lease is now existing or subsequently created and whether or not a memorandum of such lease has been filed with the United States Surface Transportation Board, in order to secure each Debtor's performance of its obligations as described in the Credit Agreement and Security Agreement, in each case with respect to clauses (i) and (ii), to the extent constituting Collateral (as defined in the Security Agreement); provided, however, that any buyer of locomotives, railcars and other rolling stock in the ordinary course of the Debtors' business takes free of the Administrative Agent's security interest in such locomotives, railcars and other rolling stock and, in such cases where all of the locomotives, railcars and other rolling stock subject to a particular lease are sold to such buyer in the ordinary course of business, any contemporaneous assignment of such lease to such buyer shall be free of the Administrative Agent's security interest in such lease.

This Memorandum may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
