MEMORANDUM OF SECOND AMENDED AND RESTATED COLLATERAL AGENCY AGREEMENT RELEASE, dated as of February 20, 2015, by and among **TRINITY RAIL LEASING I L.P.**, a Texas limited partnership (“**Lessee**”), **TRLI 2001-1A RAILCAR STATUTORY TRUST**, a Connecticut statutory trust, all of the activities of which are conducted by U.S. Bank National Association, as successor-in-interest to State Street Bank and Trust Company of Connecticut, National Association, a national banking association, not in its individual capacity but solely as owner trustee, **TRLI 2001-1B RAILCAR STATUTORY TRUST**, a Connecticut statutory trust, all of the activities of which are conducted by U.S. Bank National Association, as successor-in-interest to State Street Bank and Trust Company of Connecticut, National Association, a national banking association, not in its individual capacity but solely as owner trustee, and **TRLI 2001-1C RAILCAR STATUTORY TRUST**, a Connecticut statutory trust (TRLI 2001-C Railcar Statutory Trust, together with TRLI 2001-A Railcar Statutory Trust and TRLI 2001-B Railcar Statutory Trust, collectively, the “**Trust**”), all of the activities of which are conducted by U.S. Bank National Association, as successor-in-interest to State Street Bank and Trust Company of Connecticut, National Association, a national banking association, not in its individual capacity but solely as owner trustee (collectively, the “**Owner Trustees**”) and **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as successor-in-interest to LaSalle Bank National Association, a national banking association, as Indenture Trustee (together with any successor indenture trustee, the “**Indenture Trustee**”), **TRINITY RAIL MANAGEMENT, INC.** (“**TRMI**”), **TRINITY INDUSTRIES LEASING COMPANY**, acting in its capacity as manager (“**Manager**”) and **THE BANK OF NEW YORK MELLON TRUST COMPANY, NATIONAL ASSOCIATION**, as collateral agent (“**Collateral Agent**” and together with Indenture Trustee, Lessee, TRMI, Manager and Owner Trustees, the “**Parties**”). Capitalized terms used herein which are not defined herein shall have their respective meanings ascribed thereto as set forth in the Second Amended and Restated Collateral Agency Agreement (defined below).

WHEREAS, Lessee, Indenture Trustee, the Owner Trustees, TRMI, Manager and Collateral Agent entered into that certain Second Amended and Restated Collateral Agency Agreement, dated as of December 28, 2001 (the “**Second Amended and Restated Collateral Agency Agreement**”), a memorandum of which was recorded with the Surface Transportation Board (the “**STB**”) on December 31, 2001 at 10:53 A.M. under Recordation No. 23800-F, covering, *inter alia*, the railroad equipment listed in Schedule A hereto, bearing the equipment numbers of Lessee shown in said Schedule A, and all additions and alterations thereof, replacements thereof and substitutions therefor (the “**Equipment**”);

WHEREAS, Lessee and Collateral Agent are terminating the pledge of the Equipment under the Second Amended and Restated Collateral Agency Agreement and all liens on the Equipment thereunder are released, and all railroad equipment currently covered under the documents on file in STB Recordation No. 23800-F and the secondary documents filed under that recordation number are hereby released without recourse or warranty; and

WHEREAS, the Parties wish to show for the public record the release of the lien on the Equipment under the Second Amended and Restated Collateral Agency Agreement.

NOW, THEREFORE, to accomplish the foregoing, the Parties are filing this Memorandum of Second Amended and Restated Collateral Agency Agreement Release with the STB pursuant to 49 USC section 11301(a).
