

**TERMINATION OF LEASE OF RAILROAD EQUIPMENT NO. 1**  
dated as of June 3, 2016.

**WHEREAS, SunTrust Equipment Finance & Leasing Corp** as owner (the "Owner") and **Duluth, Winnipeg and Pacific Railway Company** (predecessor-in-interest to **Wisconsin Central Ltd.**) as lessee (the "Lessee") entered into a Lease of Railroad Equipment No. 1 dated as of February 1, 2009, as supplemented by Closing Supplement No. 1 dated as of March 31, 2009, (collectively, the "Lease") covering the one-hundred fifty (150) 60'9" Plate F 286K double plug door boxcars, built by Gunderson LLC in 2009, marked and numbered **DWC 794150 to DWC 794299 inclusive** (the "Equipment");

**WHEREAS,** to evidence its interest in the Equipment and the Lease, a Memorandum of Lease of Railroad Equipment No. 1 dated as of February 1, 2009, was filed at (i) the Surface Transportation Board on March 25, 2009 at 10:30 A.M. under primary recordation number 27859 and (ii) the Registrar General of Canada on March 25, 2009 at 4:27 P.M.;

**AND WHEREAS,** as of the date hereof, (i) the Owner and Lessee desire to terminate the Lease and (ii) the Lessee has fully discharged and satisfied its obligations thereunder.

**NOW, THEREFORE,** the Owner hereby (i) terminates the Lease of the Equipment and (ii), for greater certainty, releases any security interest in the Equipment.
