PARTIAL TERMINATION OF SECURITY AGREEMENT

SURFACE TRANSPORTATION BOARD

THIS PARTIAL TERMINATION OF SECURITY AGREEMENT ("Termination") is made as of November 30, 2015, by BOKF, NA dba Bank of Arkansas ("Secured Party") for the benefit of Everest Railcar Services, Inc. ("Debtor").

1. Recitals:

- a. Secured Party and Debtor entered into a Commercial Security Agreement dated as of July 29, 2013 ("Agreement") pursuant to which the Secured Party acquired a security interest in certain railroad cars ("Railcars"), as more particularly described in the Agreement.
- b. Secured Party and Debtor entered into a certain Memorandum of Security Agreement ("Memorandum") evidencing the above-described Agreement, which Memorandum was filed at the Surface Transportation Board on August 20, 2013, having recordation number 30899.
- c. Certain of the Railcars, as more particularly described on Exhibit A hereto, have been released and are no longer covered by the Agreement.


2. Termination of Security Interest:
