

MEMORANDUM OF COLLATERAL ASSIGNMENT OF  
MASTER RAILCAR SERVICE AGREEMENT

THIS MEMORANDUM OF COLLATERAL ASSIGNMENT OF MASTER RAILCAR SERVICE AGREEMENT is made and entered into as of September 11, 2015 (this "**Memorandum**"), by and among SUNTRUST EQUIPMENT FINANCE & LEASING CORP. (together with its successors and assigns, "**Secured Party**") and TRINITY CHEMICAL INDUSTRIES, L.L.C. ("**Trinity Industries**"), with reference to the following:

1. Pursuant to a Collateral Assignment of Sublease Agreement dated as of September 11, 2015 (the "**Assignment**"), Trinity Industries has collaterally assigned to Secured Party all of Trinity Industries' right title and interest in and to the Sublease (as hereinafter defined), solely as it relates to the railcars described on Schedule A attached hereto (the "**Railcars**"). As used herein, the term "**Sublease**" means (a) each rider relating to the Railcars entered into pursuant the Master Railcar Service Agreement dated as of December 5, 2013 (the "**Phillips Master Agreement**"), by and between Guarantor, as lessor, and Phillips 66 Company, as lessee ("**Sublessee**"), including, without limitation, Rider Number 3 dated as of August 1, 2014, and (b) the Phillips Master Agreement, solely as it relates to each such rider and the Railcars, in each case, as amended.
2. The Assignment shall be effective as of the date first set forth above and Trinity Industries' and Sublessee's use of the Railcars shall be subject to the terms and conditions as set forth in the Assignment.

This Memorandum may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Collateral Assignment of Master Railcar Service Agreement.






