


WITNESSETH

THE WARRANTIES IN THE CONTRACT ARE EXCLUSIVE AND ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR USE.

Seller hereby warrants that it has and does hereby convey to Customer good and marketable title to the Cars free from all liens and encumbrances, except as set forth in the Agreement and those created by or through Customer.
