**COMPLETE RELEASE OF RIDER NO. 4  
AND RIDER NO. 5**

This Complete Release (the "Release") dated as of February 7, 2014 releases the lien created by that certain Rider No. 4 to Master Lease Agreement dated as of February 17, 2006 and that certain Rider No. 5 to Master Lease Agreement dated as of February 17, 2006 (the "Agreements") between The David J. Joseph Company, as Lessor ("Joseph") and Mittal Steel USA, Inc., as Lessee ("Lessee"), with respect to six (6) railcars (hereinafter, the "Railcars").

WHEREAS, Joseph and Lessee memorialized the Agreements of record by filing a Memorandum of Rider No. 4 to Master Lease Agreement dated as of February 17, 2006 (the "Memorandum of Rider 4") with the Surface Transportation Board (the "STB"); and

WHEREAS, the Memorandum of Rider 4 was recorded with the STB under Recordation Number 26244-D;

WHEREAS, Joseph and Lessee memorialized the Agreement of record by filing a Memorandum of Rider No. 5 to Master Lease Agreement dated as of February 17, 2006 (the "Memorandum of Rider 5") with the Surface Transportation Board (the "STB"); and

WHEREAS, the Memorandum of Rider 5 was recorded with the STB under Recordation Number 26244-E;

NOW THEREFORE, in consideration of the premises and mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt of which is hereby acknowledged, Joseph acknowledges as follows:

1. The Memorandum of Rider 4 and the Memorandum of Rider 5 are hereby terminated. The party hereby releases all rights, interests or claims to, and all liens and encumbrances upon, the Railcars as given under the Memorandums.
2. The parties desire to execute this Release for purposes of memorializing of record the agreements set forth herein.
3. This Release shall be filed with the STB under Recordation No. 26244-N.
