

Memorandum of Schedule No. 20 dated as of February 1, 2015 to a Lease Agreement dated as of April 1, 2014 by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and D & I Silica, LLC, a Delaware limited liability company ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor one hundred (100) 3,250 cf cement covered hopper railcars, 286,000 lbs. GRL with three 30" circular loading hatches and two low profile discharge gates built to Gunderson LLC Specification R12-23 dated 6/03/14 bearing car marks and numbers listed on Exhibit A attached hereto.
