MEMORANDUM OF RAILCAR LEASE AGREEMENT

1/3 THIS MEMORANDUM OF RAILCAR LEASE AGREEMENT is made and entered into as of this day of February, 2015 by and between **Tealinc, Ltd.** a Montana corporation (the "Lessor") and **Graymont (PA) Inc.**, a Pennsylvania corporation (the "Lessee") with reference to the following:

1. Lessor has agreed to lease to Lessee, and Lessee has agreed to lease from Lessor various railcars pursuant to one or more Schedules to be entered into by Lessor and Lessee from time to time, all as more particularly described in that certain Master Railcar Service and Lease Agreement No. GPA001 dated March 24, 2006 between Lessor and Lessee (hereinafter referred to as the "Lease").

2. Pursuant to Schedule No. GPA004 to the Lease, Lessor has agreed to lease to Lessee and Lessee has agreed to lease from Lessor the five (5) 4600 to 4750 cube covered hopper Railcars bearing the reporting marks and numbers indicated on Exhibit A hereto, all as more particularly described in the Lease.

3. The Lease shall be effective as of the execution date thereof and shall be subject to the term of the Lease, as provided therein.
