**NOTICE OF FULL TERMINATION OF LEASE**

The undersigned, WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION (successor In interest through mesne assignments to FIRST SECURITY BANK OF UTAH, NATIONAL ASSOCIATION), not personally but in its capacity as Owner Trustee (under each of BN Trust No. 89-1, BN Trust No. 89-2, BN Trust No. 89-3, BN Trust No. 89-4 and BN Trust No. 89-5), and Lessor, publishes this notice that the Equipment Lease Agreement dated as of November 1, 1989 (as supplemented from time to time, the "Lease") between the Lessor and Burlington Northern Railroad Company (now known as BNSF Railway Company), as Lessee, has expired in accordance with its terms and has been terminated.

The Lease was duly recorded with the Interstate Commerce Commission (the "ICC" now the Surface Transportation Board) on November 22, 1989 under Recordation Number 16621 and duly recorded with the Registrar General of Canada ("RGC") on November 22, 1989 under Document Key 2084. Lease Supplement No. 1, was duly recorded with the ICC on November 22, 1989 under Recordation Number 16621-A and the RGC on November 22, 1989 under Document Key 2086, and Lease Supplement No. 2, was duly recorded with the ICC on December 29, 1989 under Recordation Number 16621-D and the RGC on June 4, 1990 under Document Key 2082.

The Lessor hereby acknowledges that all obligations of the Lessee under the Lease with respect to all railroad equipment covered by the Lease have been duly performed and satisfied and that there remain no further obligations on the part of the Lessee under the Lease with respect to such railroad equipment except those terms of the Lease that by their express terms survive termination.

The Lessor does hereby authorize the filing and recording of this Notice with the United States Surface Transportation Board and the RGC in order to give effect to the foregoing.




