

MEMORANDUM OF SCHEDULE #1 TO FULL SERVICE MASTER LEASE AGREEMENT

THIS MEMORANDUM OF SCHEDULE #1 TO FULL SERVICE MASTER LEASE AGREEMENT is effective as of May 6, 2013, by and between WELLS FARGO EQUIPMENT FINANCE, INC. D/B/A MIDWEST RAILCAR CAPITAL EQUIPMENT COMPANY, a Minnesota Corporation ("Lessor"), and WEST RANGE RECLAMATION, LLC, a Colorado limited liability company and TIMBERRAIL SERVICES, LLC, a Wyoming limited liability company (jointly and severally, the "Lessee"), with reference to the following:




