WITNESSETH

WHEREAS, RBS Asset Finance, Inc. ("RBS") and Lessee are parties to that certain Memorandum of Master Net Railcar Lease dated as of January 4, 2010 (the "Lease"), which has been recorded with the Surface Transportation Board (the "STB") on January 4, 2010, under Recordation Number 28267. The Lease was assigned by RBS to Lessor as evidenced by that certain Memorandum of Lease Assignment dated January 4, 2010, which has been recorded with the STB on February 2, 2010, under Recordation Number 28267-A.

WHEREAS, the duties and obligations of the parties to the Lease have been satisfied and discharged.




