PARTIAL TERMINATION OF MEMORANDUM OF SECURITY AGREEMENT

THIS PARTIAL TERMINATION OF MEMORANDUM OF SECURITY AGREEMENT is made as of November 27, 2013 by JPMorgan Chase Bank, N.A. as Collateral Agent (herein "Collateral Agent") and Westlake Vinyls, Inc and Westlake PVC Corporation (herein collectively as "Debtor").

WITNESSETH:


WHEREAS, Collateral Agent and Debtor are parties to that certain Memorandum of Security Agreement dated as of September 30, 1999 (the "Memorandum"), which has been recorded with the Surface Transportation Board (the "Board") on September 30, 1999 under Recordation Number 22450; and that certain Amended and Restated Memorandum of Security Agreement dated as June 21, 2002 (the "Amendment"), which has been recorded with the Board on June 26, 2002 under Recordation Number 22450-A; and

WHEREAS, the duties and obligations of the parties to the Memorandum and Amendment have been satisfied and discharged with respect to one (1) Hopper Railcar, numbered TEIX 007802.

NOW, THEREFORE, in consideration of the promises and covenants in the documents set forth above by reference, and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and the authority to issue and execute this document, intending to be legally bound, and recognizing the need to officially terminate the Memorandum and Amendment covering Hopper Railcar, numbered TEIX 007802 in the files of the Board, Collateral Agent and Debtor hereby terminate and cancel the Memorandum and Amendment of the Hopper Railcar numbered TEIX 007802 as of the date herein first written above; provided that this termination does not apply to provisions of the Memorandum and Amendment stated to survive such termination.


