

("MEMORANDUM")
As of September 25, 2015,

THIS MEMORANDUM evidences the termination of that certain MEMORANDUM OF HEAD LEASE AGREEMENT (2003-C), dated as of September 30, 2003, between STATE OF CONNECTICUT (the "Head Lessor") and CTDOT 2003-C STATUTORY TRUST (the "Head Lessee"). Capitalized terms used herein and not otherwise defined shall have the respective meanings set forth in the Head Lease (defined below) or Appendix A to the Participation Agreement (2003-C), dated as of September 30, 2003, among the State of Connecticut, as Lessee, CTDOT 2003-C Statutory Trust, as Lessor, Comerica Leasing Corporation, as Equity Investor, FSA Global Funding, as Lender, Premier International Funding Co., as Debt Payment Undertaker and Wells Fargo Bank Northwest, National Association, as Trustee and in its individual capacity only to the extent expressly provided therein.

WHEREAS, Head Lessor and Head Lessee entered into that certain Head Lease Agreement (2003-C), dated September 30, 2003, as supplemented by the Head Lease Supplement (2003-C), dated September 20, 2003 (the "Head Lease") , covering all the rail equipment identified therein;

WHEREAS, on September 25, 2015, the Head Lessor and Head Lessee terminated the Head Lease (the "Termination");

WHEREAS, the Head Lessor and Head Lessee now wish to clarify the public record to reflect the Termination;

NOW THEREFORE, the Head Lessor and Head Lessee record this Memorandum to serve as public notice that the Memorandum of Head Lease Agreement filed with the Surface Transportation Board on September 30, 2003, under Recordation No. 24624, has been terminated in all respects.




