MEMORANDUM OF TERMINATION OF LEASE


Memorandum of Termination of Lease dated as of January 21, 2014 by Mitsui Rail Capital, LLC, a Delaware limited liability company ("*Lessor*").

WITNESSETH:

1. Lessor and Peabody Coaltrade, LLC (formerly known as Coaltrade, LLC) (the "*Lessee*") are parties to that certain Lease Agreement (the "*Lease Agreement*"), dated September 9, 2005, and Schedule No. 1 thereto dated as of September 9, 2005 (the "*Schedule*"), whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars described in such Schedule. (The Schedule, incorporating the terms of the Lease Agreement, is herein referred to as the "*Lease*.")
2. Notice of the Lease has been put of record by the filing of a Memorandum of Lease Agreement dated as of September 9, 2005 with the Surface Transportation Board on September 9, 2005 under Recordation Number 25841.


