

This MEMORANDUM OF ASSIGNMENT is dated as of May 1 2014, by and between COMPASS RAIL VI CORPORATION, a California corporation ("Seller") and FIRST UNION RAIL CORPORATION, a North Carolina corporation ("Purchaser").

The parties to this Memorandum hereby acknowledge and confirm the following:

1. Seller, as lessor, has leased certain railroad cars more particularly described in Exhibit A attached hereto (the "Cars") pursuant to that certain Master Lease Agreement dated as of March 2, 2006, Rider No. 1, Rider No. 2, Rider No. 3, and Rider No. 4 thereto (Rider No. 1, Rider No. 2, Rider No. 3, Rider No. 4, and the Master Lease Agreement as it pertains to Rider No. 1, Rider No. 2, Rider No. 3 and Rider No. 4, each as amended, modified, extended, supplemented, restated and/or replaced from time to time, the "Lease") to Axiall Corporation.
