

SCHEDULE NO. 1

This is a Memorandum of Schedule No. 1 dated as of December 15, 2015, to a Lease Agreement dated as of December 15, 2015, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and Hart AgStrong LLC, a Georgia limited liability company ("Lessee").


