PARTIAL TERMINATION OF SECURITY AGREEMENT

THIS PARTIAL TERMINATION OF SECURITY AGREEMENT ("Termination") is made as of November 13, 2013 by Wells Fargo Bank Texas, N.A. (the "Secured Party"), for the benefit of Bob Atnip (the "Debtor").

1. Recitals.

A. Secured Party and Debtor entered into a Security Agreement dated as of October 15, 2001 (the "Agreement") pursuant to which the Secured Party acquired a security interest in each and every railroad car of every type, kind, name or description then owned by Debtor or thereafter acquired. The Agreement is on file at the Surface Transportation Board under Recordation No. 23764 filed on _____ at _____ AM.
