

MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

BETWEEN

AND

Memorandum of Assignment and Assumption Agreement made and entered into as of September 12, 2014, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Assignor"), and MUL Railcars Leasing, LLC, a Delaware limited liability company ("Assignee").

WITNESSETH:



Assignor, as Lessor, leased to Equistar Chemicals, LP ("Lessee") sixty-five (65) 6,250 c.f., lined covered hopper railcars, marked and numbered AOKX 90135 through AOKX 90199, inclusive (the "Cars"), pursuant to that certain Lease Agreement dated as of August 1, 2013 (the "Lease Agreement"), and Schedule No. 3 thereto dated as of January 31, 2014, as amended by Amendment No. 1 to Lease Schedule dated August 29, 2014 (as amended, "Schedule No. 3", and Schedule No. 3 and the Lease Agreement as it relates to Schedule No. 3 collectively, the "Lease").


