PARTIAL TERMINATION OF SECURITY AGREEMENT

THIS PARTIAL TERMINATION OF SECURITY AGREEMENT ("Termination") is made as of November 13, 2013 by Wells Fargo Bank, N.A fka First Interstate Bank of Texas N.A. (the "Secured Party"), for the benefit of Bob Atnip (the "Debtor").

1. Recitals.

A. Secured Party and Debtor entered into a Commercial Pledge Agreement dated as of March 31, 1995 (the "Agreement") pursuant to which the Secured Party acquired a security interest in each and every railroad car of every type, kind, name or description then owned by Debtor or thereafter acquired.
