**MEMORANDUM OF LEASE**

**RIDER NO. 8**

This is a Memorandum of Rider No. 8 dated as of March 2nd, 2015 to a Lease Agreement made and entered into as of March 1, 2000 and amended and restated as of December 1, 2012, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, as successor-in-interest to Greenbrier Leasing Corporation ("Lessor"), and Quebec Gatineau Railway Inc., a Quebec corporation ("Lessee").

**WITNESSETH:**

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor, two (2) used 50-foot, Plate F boxcars with ten-foot plug doors, 286,000 lbs. GRL, bearing reporting marks and numbers CRLE 15493 and CRLE 15494.
2. Rider No. 8 to the Lease Agreement will be effective as of the date first set forth hereinabove and will remain in effect through the lease term, as described in the Lease Agreement and Rider No. 8, as each may be amended from time to time.


