MEMORANDUM OF LEASE TERMINATION (PARTIAL)

MEMORANDUM OF LEASE TERMINATION (PARTIAL), dated as of March 18, 2015, by PROGRESS RAIL LEASING CORPORATION, a Delaware corporation (the "Lessor"). Capitalized terms used herein which are not defined herein shall have their respective meanings ascribed thereto as set forth in the Lease (defined below).

WHEREAS, Lessor and INVISTA S.a.r.l. entered into that certain Schedule 1 dated as of April 24, 2013, as amended by that certain Agreement and First Amendment to Schedule 1 dated as of October 6, 2014 (as amended, "Schedule 1"), which incorporates by reference that certain Master Locomotive Lease Agreement (Full Service) dated as of April 24, 2013 (the "Master Lease" and, together with Schedule 1, the "Lease"), a Memorandum of which was recorded with the Surface Transportation Board ("STB") on May 23, 2013, at 08:00 AM, under Recordation No. 30735, covering the Equipment described therein.

Effective the date hereof, the Lease is terminated solely with respect to the Equipment described on Exhibit A hereto (the "Released Equipment"). This document constitutes a release of all interests, claims, liens or encumbrances solely with respect to the Released Equipment covered by the Lease.

The Lessor is filing this Memorandum of Lease Termination with the STB pursuant to 49 USC Section 11301(a). This Memorandum of Lease Termination is executed without prejudice to the rights or obligations of the parties which expressly survive termination of the Lease or the termination agreement among the parties.


