PARTIAL RELEASE AND TERMINATION OF LEASE AGREEMENT

The undersigned, **THE HUNTINGTON NATIONAL BANK**, a national banking association (“Lessor”), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge any and all security interest in: the railcars described on Exhibit No. 1 attached hereto (the “Cars”), which security interest was granted to Lessor by **THE CIT GROUP/CORPORATE AVIATION, INC.** (“Grantor”) pursuant to that certain Equipment Lease Agreement dated as of September 28, 2012, between Grantor and Lessor (the “Lease Agreement”), and Lease Supplement No. 2 thereto dated as of September 28, 2012 (the “Lease Supplement”). The Lease Supplement and the Lease Agreement, to the extent incorporated in or relating to the Lease Supplement, and solely as it pertains to the Lease Supplement and the Cars, are hereinafter collectively referred to as the “Head Lease”, which Head Lease was duly filed and recorded with the Surface Transportation Board on September 28, 2012 under Recordation Number 21833-Z.

Effective immediately herewith, the Head Lease referenced above is terminated, and the Cars identified on Exhibit No. 1 hereto shall be free and clear of any liens, encumbrances and interests of Lessor. Lessor agrees to and authorizes the filing by Grantor, or its designee, of this Partial Release and Termination of Lease Agreement with the Surface Transportation Board and Registrar General of Canada to terminate any filings evidencing Lessor’s security interest under the Head Lease.

The terminations, releases and discharges set forth herein are made in each case without prejudice to the rights or obligations of the parties which expressly survive the termination of the Head Lease.
