MEMORANDUM OF ASSIGNMENT OF LESSEE'S INTEREST IN LEASE

THIS MEMORANDUM OF ASSIGNMENT OF LESSEE'S INTEREST IN LEASE (this "*Memorandum*") is dated as of September 5, 2013 by and between FTS INTERNATIONAL SERVICES, LLC f/k/a FRAC TECH SERVICES, LLC, a Texas limited liability company ("*Assignor*"), and FML TERMINAL LOGISTICS, LLC, an Ohio limited liability company ("*Assignee*").

1. Assignor and Macquarie Rail Inc., a Delaware corporation ("*Lessor*") have entered into a Railcar Leasing Agreement (Full Service), dated as of March 31, 2010 (the "*Lease*"), under the terms of which Lessor has agreed to lease to Assignor 150 3,281 ft³ 286,000 gross rail load covered hoppers (each a "*Railcar*") pursuant to Rider 2 to the Lease (the "*Rider*"), which Railcars bear marks and numbers as follows:
