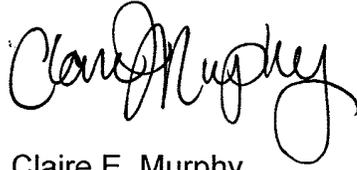

NOTICE OF PARTIAL LEASE TERMINATION


