

**NOTICE OF TERMINATION**

The undersigned, THE HUNTINGTON NATIONAL BANK, as Lessor (hereinafter "*Lessor*") for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby give notice that it has terminated that certain Financing Lease Schedule No. 6243.33 dated as of March 21, 2012, as amended, modified or supplemented (hereinafter the "*Schedule*") with RAIL CONNECTION, INC., as Lessee ("*Lessee*").

Pursuant to the Schedule, a Memorandum of Lease (hereinafter "*Memorandum*") was duly filed and recorded with the Surface Transportation Board (the "*Board*") on March 29, 2012 and assigned Recordation Number 30137. This document constitutes a release of all interests, claims, liens, or encumbrances by the Lessor over the Railroad Equipment fully described in the Schedule and Memorandum (the "*Rail Equipment*").
