MEMORANDUM OF TERMINATION

THIS MEMORANDUM OF TERMINATION, dated as of August 8, 2014, by and among PACER INTERNATIONAL, INC. ("Lessee"), and PNC EQUIPMENT FINANCE, LLC (the "Lessor" and together with Lessee, the "Parties").

WHEREAS, Lessor and Lessee entered into that certain Railcar Lease Agreement dated as of February 28, 2012 including Schedule No. 1 dated February 28, 2012 and Schedule No. 2 dated June 8, 2012 (together with all riders, schedules, and amendments thereto collectively referred to herein as the "Lease");

WHEREAS a Memorandum of Lease was recorded (i) on February 28, 2012 at 12:30 p.m. with the Surface Transportation Board ("STB") under Recordation No. 30108 covering the equipment described therein and (ii) on August 17, 2012 at 11:00 a.m. with STB under Recordation No. 30335 covering the equipment described therein;

WHEREAS, effective the date hereof, the Lease is terminated and all Lessor's liens are released with respect to the Lease and the equipment described on Schedule A hereto (the "Terminated Units");

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid termination of the Lease and the Lessor's lien on the Terminated Units, and the respective interests therein of the Parties

NOW, THEREFORE, to accomplish the foregoing, the Parties are filing this Memorandum of Lease Termination with the STB pursuant to 49 USC Section 11301(a) and with the Registrar General of Canada pursuant to Section 105 of the Canada Transportation Act.




