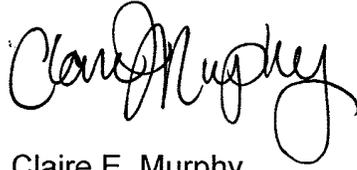

RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "Release") is made this 23rd day of March, 2016, by WILLIAMS SODIUM PRODUCTS COMPANY (the "Lender") pursuant to that certain Credit and Security Agreement, dated as of March 26, 2002 (the "Security Agreement"), between Lender and American Soda, L.L.P. (the "Borrower").

WHEREAS, the Security Agreement created a lien and security interest in favor of the Lender in and to the railroad equipment owned by Borrower and set forth on Exhibit B to the Security Agreement (the "Pledged Collateral").

WHEREAS, the Security Agreement was duly filed and recorded with the Surface Transportation Board on April 3, 2002 under Recordation Number 23922.

WHEREAS, the Borrower and the Lender now desire to release, terminate and cancel the Lender's security interest in and mortgage lien upon all right, title and interest of the Borrower in, to and under the Pledged Collateral.
