

MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

This MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT (this "**Memorandum of Assignment**") is made and entered into as of *November 20*, 2015, among **General Electric Capital Corporation** ("**Assignor**") and **CF Equipment Leases, LLC** ("**Assignee**"), with reference to the following:

1. Pursuant to that certain Master Lease Agreement dated as of July 15, 1997 (the "**Master Lease**") between General Electric Capital Corporation ("**Assignor**") and Great Lakes Carbon Corporation ("**Lessee**") and that certain Equipment Schedule No. 004 dated as of December 31, 1998 (the "**Schedule**"; the Master Lease and the Schedule, together, the "**Lease**") between Assignor and Lessee, Assignor agreed to furnish to Lessee, and Lessee agreed to lease from Assignor, 114 covered hopper cars numbered GLCX 8030-8104, inclusive, 8106-8112, inclusive, 8114-8126, inclusive, 8165-8169, inclusive, and 8171-8184, inclusive (the "**Cars**").

2. The Lease was evidenced by that certain Memorandum of Lease Agreement dated as of December 31, 1998 between Assignor and Lessee, recorded with the Surface Transportation Board on January 4, 1999 as Recordation No. 21931.

3. Pursuant to a Contribution and Assumption Agreement dated as of October 1, 2015 (the "**Assignment**"), Assignor assigned to Assignee, and Assignee assumed from Assignor, all of Assignor's right, title and interest in, to and under the Lease and the Cars.

4. This Memorandum of Assignment is being recorded with the Surface Transportation Board pursuant to 49 U.S.C. Section 11301(a) for the purpose of giving record notice and evidence of the Assignment, the Lease and the Cars.

5. This Memorandum of Assignment may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment.
