

**MEMORANDUM OF LEASE**

This MEMORANDUM OF LEASE is made and entered into as of May 27, 2014, between NorLease, Inc., a Delaware corporation ("Lessor"), and Olin Chlor Alkali Logistics, Inc., a Delaware corporation ("Lessee"), with reference to the following:

1.
