MEMORANDUM OF TERMINATION OF LEASE


Memorandum of Termination of Lease dated as of June 1, 2015 by Mitsui Rail Capital, LLC, a Delaware limited liability company ("**Lessor**").

WITNESSETH:

1. Lessor and ProTrade Transportation Services, Ltd. (the "**Lessee**") are parties to that certain Full Service Lease Agreement (the "**Lease Agreement**"), dated June 24, 2010, and Schedule No. 5 thereto dated as of May 25, 2011 (the "**Schedule**"), whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars described in such Schedule. (The Schedule, incorporating the terms of the Lease Agreement, is herein referred to as the "**Lease**.")


