Memorandum of Schedule No. T4 dated April 29, 2015, effective as of November 1, 2014, to a Lease Agreement made and entered into May 9, 2011 and effective October 1, 2010, and amended effective July 31, 2013, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and EOG Resources, Inc., a Delaware corporation ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor one hundred twenty-six (126) new, 29,500 gallon capacity, non-coiled, non-lined, DOT 111A100W1 tank railcars built in accordance with the specifications outlined in CPC-1232 and meeting all rules proposed by the Pipeline and Hazardous Materials Safety Administration dated 08/01/2014 for Enhanced Tank Car Standards - Option 2, 286,000 lbs. 
