THIS MEMORANDUM OF SCHEDULE #17 TO FULL SERVICE MASTER LEASE AGREEMENT is effective as of March 4, 2014, by and between MIDWEST RAILCAR CORPORATION, an Illinois Corporation ("Lessor"), and U.S. SILICA COMPANY, a Delaware Corporation ("Lessee"), with reference to the following:


