Memorandum of a Lease Agreement and Rider No. 4 thereto, made and entered into as of March 1, 2015, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor"), and Louisiana-Pacific Corporation, a Delaware corporation ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and Lessee has agreed to lease from Lessor one hundred eighty-one (181) 73-foot, 110-ton riserless deck center partition flatcars with fabricated top chords, designed for a gross rail load of 286,000 lbs., marked and numbered as set forth in Exhibit A attached hereto.
2. Rider No. 4 to the Lease Agreement shall be effective as of the date first set forth hereinabove and shall be subject to the lease term set forth in the Lease Agreement and Rider No. 4, as each may be amended from time to time.


