

MEMORANDUM OF LEASE AGREEMENT

1. Pursuant to Lease Schedule No. 015 dated as of September 23, 2015, to that certain Master Railcar Lease Agreement dated as of January 1, 2015 (collectively, the "Lease Agreement"), Lessor agreed to lease to Lessee, and the Lessee agreed to lease from Lessor, the railcars described on Schedule A attached hereto (the "Railcars").

3. This Memorandum of Lease Agreement may be executed in duplicate originals and any number of counterparts and by different parties in separate counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.


