

AMENDMENT TO MEMORANDUM OF LEASE AGREEMENT, dated May 1, 2015, between THE HUNTINGTON NATIONAL BANK (the "**Lessor**"), and COVANTA SUSTAINABLE SOLUTIONS, LLC formerly known as Covanta 4Recovery, L.P. (the "**Lessee**").
