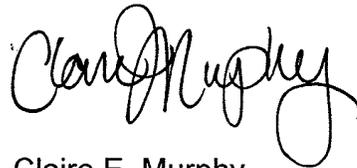

MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE
(Surface Transportation Board)

THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE (this "Memorandum") dated as of June 3, 2015 is between **ALLIED ENTERPRISES, INC.** (the "Assignor") and **RLH1 LLC** (the "Assignee").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. The Assignor, as lessor, has leased to OmniSource Corporation, as lessee (the "Lessee"), sixty three (63), 1981 built mill gondola railcars, as more fully identified on Schedule 1 attached hereto (the "Railcars") under that certain Lease Agreement dated as of March 31, 2008; Rider No. 1 thereto dated March 14, 2008; Rider No. 1A thereto dated April 4, 2008; Rider No. 2 thereto dated September 1, 2011; and Rider No. 3 thereto dated January 7, 2015, by and between Assignor and OmniSource Corporation, as Lessee (collectively, the Lease").

B. The Assignor, as assignor, and the Assignee, as assignee, are parties to that certain Assignment of Lessor's Interest in Lease, dated as of even date herewith, pursuant to which the Assignor has assigned to the Assignee the rights of "Lessor" under the Lease. The terms of the assignment are more particularly set forth in the above-referenced Assignment of Lessor's Interest in the Lease.

C. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first above written. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.
